- Step 2:** IT Carlow will send applicants a 'Football Applicant Information Form' by email once we receive the applicant data from the CAO.
- Please complete and Return the 'Football Applicant Information Form' asap.
 - Applicants who do not submit a form will not be considered for a place on the course.
- Step 3:** Football Applicant Information Forms will be reviewed by course tutors.
- Step 4:** Applicants will receive an email either:
- a.) Inviting the applicant to attend an Interview / Trial process, or
 - b.) Informing the applicant that they will not be receiving an invitation to the Interview / Trial process and therefore will not be receiving an offer of a place on the programme.
- Step 5:** Following the Portfolio process (i.e. receipt of a 'Football Applicant Information Form' and the completion of the Interview / Trial process) final selection for places on the programme is determined on the basis of CAO points.
- Step 6:** Offers are distributed via the CAO system in mid-August each year.
